## Challenge's

- **69% of CCC reporting Enrollments Stationary or Reduced**
- **Funding SHS Enrollment Dependent**
- **Inconsistent Compliance locally w/Title V. Ed. Code**
- **SHS Nursing Leadership Retiring Imperative to Replace**
- **Use of Restricted Funds Non-compliant under Title V.**

## Mitigating Challenges

### **Enrollment Directly Tied to SHS Revenue**

- **Advocate to Charge Maximum SHF**
- **Watch your Budget for Un-Lawful Compliance**
- **Explore Alternative Revenue Streams i.e.,**
  - **Family Pact, LEA, Partner with ASG, Seek Grants**
- **Discuss, Engage in Legislative Action for Funding Stabilization**
- **LEA Advocacy for CCC State Plan Amendment language**

## Mitigating Challenges

### **Attrition of SHS Nursing Leadership**

- Advocate adherence to Title V. Minimum Qualifications (Ed Code) Section 53411 (Overall SHS Responsibility)
- Reach out to Graduate Nursing Programs for links
- Establish Source of Nursing Recruitment for CCC's

## Mitigating Challenges

- **Student Health Fee's Governed by Title V. Sections 76355, 54708, 54702, informs SHF Restrictions:**
  - **Authorized SHF Expenditures, SHF Increases**
  - **Local Control of SHF's, Start-up Costs for SHS**
  - **Salaries of those who directly provide SHS**
  - **Travel limited to SHS personnel etc . . .**
